- (B) ACQUISITION OF 45% OF SHARES IN PPL HOLDINGS PTE LTD

Reference is made to the Company's announcements of 17 April 2010, 21 June 2010, 26 June 2010, 2 September 2010 and 6 October 2010 in relation to, *inter alia*, the Placement and the Acquisition. Capitalised terms used herein, unless otherwise defined, shall have the meaning ascribed to them in the aforesaid announcements.

茲提述本公司 2010 年 4 月 17 日, 2010 年 6 月 21 日, 2010 年 6 月 26 日, 2010 年 9 月 2 日和 2010 年 10 月 6 日提及新股發行和收購股權的公告。除另有界定者,本公告中使用的詞彙與前述公告所界定者具有相同含義。

## (A) PLACEMENT COMPLETION完成新股發行

Further to the Company's announcement of 6 October 2010 in relation to the receipt of in-principle approval from the SGX-ST for the listing of and quotation for the New Shares, the New Shares have today been allotted and issued to the Investor pursuant to completion of the Placement in accordance with the Second Deed of Amendment and Restatement of Placement Agreement. At the request of the Investor, the New Shares have been allotted and issued to the Investor in scrip form.

繼公司在2010年10月6日公告收到新交所給予新股發行及報價的原則性同意批複,公司已於今日根據新股發行協議的第二次修訂及重述契約的規定,向投資者(即QD Asia Pacific Ltd.) 發行新股,完成新股發行。應投資者要求,新股份已以實物股票形式配發予投資者。

The New Shares amount to approximately 2.18% of the enlarged issued and paid-up share capital of the Company comprising 3,836,838,000 shares (excluding 239,000 treasury shares).

公司增資擴股後的已發行及繳足股本包括 3,836,838,000 股普通股(不包含 239,000 股庫藏股),新股約占公司增資擴股後的已發行及繳足股本的 2.18%。

The SGX-ST's in-principle approval is not to be taken as an indication of the merits of the Placement, the New Shares, the Shares, the Company and/or its subsidiaries.

# (B) ACQUISITION COMPLETION完成收購

In conjunction with the Placement completion, the Company has also completed the Acquisition for 45% of the shares in PPLH. Pending determination of the Litigation, the PPLH shares beneficially owned by the Company are held by the Investor as registered shareholder on trust for the Company.
