DISPOSAL OF SHARES IN THE ENTIRE SHARE CAPITAL OF JIANGSU YANGCHEN EQUIPMENT AND MATERIALS CO., LTD

出售江蘇揚宸物資有限公司所有股權

1. The Transaction 交易

The Board of Directors of Yangzijiang Shipbuilding (Holdings) Ltd. (the "Company" or the "Group") wishes to announce that its wholly-owned subsidiary, Jiangsu New Yangzi Shipbuilding Co. Ltd ("JNYSCO") had entered into an Equity Transfer Agreement (the "Agreement"), pursuant to which JNYSCO will dispose the entire 52% equity shares in the share capital of Jiangsu Yangchen Equipment and Materials Co., Ltd. ("JYCEMCO") (the "Disposal").

董事局謹代表揚子江船業控股有限公司(以下簡稱"揚子江"或"公司")宣布揚子江通過其全資子公司江蘇新揚 子造船有限公司(以下簡稱"新揚子")簽訂轉股協議出售其中國子公司-江蘇揚宸物資有限公司(以下簡稱"揚 宸")全部52%的股權。

2. Consideration 支付對價

The consideration paid for the Disposal is RMB5,200,000 which is equivalent to the 52% of total paid-up capital of JYCEMCO .

出售對價為人民幣520萬元人民幣,等值于於揚宸總註冊資本的52%。

3. General Rationale for the Disposal 出售的理由

As Jiangsu Yangchuan Equipment and Materials Co., Ltd. the Group's another 100% owned subsidiary, is having similar business scope of JYCEMCO, through consolidate similar business within the Group, the

disposal will streamline the Group's structure, to effectively control the overall administrative expenses. And it is also in the Group's best interest to dispose the loss making JYCEMCO at par value.

因集團另有一全資子公司江蘇揚船物資公司有限公司與揚宸業務範圍類似,通過整合集團內相似業務可以精簡集團架構以減少管理費用,將帳面虧損的揚宸平價轉讓出售也符合集團的最佳利益。

4. Financial Effects 財務影響

The above Disposal will not have any significant impact on the earnings per share and net tangible assets of the Group for the current financial year ending 31 December 2012.
